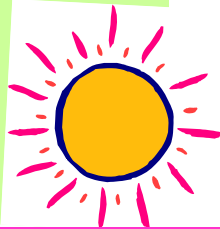

Monthly Tuition

Staff is employed according to the number of
children registered per day. Your registration
is your financial commitment to pay monthly
tuition for the number of days indicated
whether your child is present or absent. Sala-
ries and overhead expenses cannot be reduced
because of "absentee losses" in income. There-
fore, MDO must charge, regardless of attend-
ance, in order to support the enrollment space
guaranteed for your child. First Baptist Church
appreciates your cooperation in this matter. A
paid two week notice is required for withdraw-
al.
